## **Physician Payment Sunshine Act (PPSA)**

*The Physician Payment Sunshine Act (Sunshine Act) is part of the Affordable Care Act (ACA) and was recently created by Congress to ensure transparency in physicians' interactions with the pharmaceutical, biologic and medical device industries as well as group purchasing organizations. The final rule of the Act, which went into effect August 1, 2013, requires applicable manufacturers to report certain payments or transfers of value to physicians or teaching hospitals, including Beaumont Health System. All data is reported by the manufacturer to the Centers for Medicare and Medicaid Services and will be publically available. PPSA applies if your CME event is 1) attended by physicians, 2) has physician speakers, and 3) is being financially supported by a manufacturer that makes any prescription drug/biologic or any "non-exempt" medical device or supply.*

## **Stark Law**

*The Stark Law indicates that you cannot use education (CME) to induce referrals to an organization. Therefore, any CME-certified events where individuals not employed by Beaumont Health will be invited to attend must charge a registration fee. Registration fee amounts must be pre-determined and pre-approved by the CME Department. Fees can vary depending on profession (i.e. higher registration fee for a physician vs. nurse), but once fees are set, they must be applied to all registrants.*
