ALLOPATHIC (M.D.) CME REQUIREMENTS

STATE OF MICHIGAN MEDICAL LICENSE RENEWAL REQUIREMENTS

M.D.'s: 150 hrs. of CME per 3-year period

Category 1 – minimum 75 hrs.

- Attendance at or participation in a CME activity approved for *AMA PRA Category 1 Credits**
- Taking & passing ABMS specialty board certification or recertification exam (max 50 hrs.)
- Successfully completing an activity required for MOC board certification (max 30 hrs.)

Category 2 – max 75 hrs.

- Clinical instructorship for medical students engaged in a board approved postgraduate training program (max 48 hrs.)
- Presentation of a scientific exhibit, poster, paper (max 24 hrs.)
- Publication of a chapter/portion of a chapter (max 24 hrs.)
- Committee, board, council member (max 18 hrs.)

Additional Content-Specific Requirements (Online Modules Available at <https://beaumont.cloud-cme.com>)

- Training on human trafficking (one-time requirement)
- 1 hr. *minimum* medical ethics education
- 3 hrs. *minimum* pain and symptom management education
 - **NEW:** If you are a prescriber or dispenser of controlled substances, you must also complete a 1-time training in opioids and controlled substances awareness

OSTEOPATHIC (D.O.) CME REQUIREMENTS

AMERICAN OSTEOPATHIC ASSOCIATION (AOA) CME REQUIREMENTS (2019-21 Cycle)

Non-Time-Limited Diplomat: 120 total CME credits required per 3-year cycle

Time-Limited Diplomat: number of CME credits required set by each specialty certifying board

- Anesthesia:* 75 credits (at least 18, 1-A)
- Dermatology:* 60 credits (at least 15, 1-A; max 8, 1-B preceptor)
- Emergency Medicine:* 150 credits
- Family Medicine:* 150 credits (at least 75 Cat 1 with 25, 1-A)
- Internal Medicine:* 60 credits
- Neurology & Psychiatry:* 75 credits (at least 18, 1-A)
- Neuromusculoskeletal Medicine:* 60 credits (at least 30, 1-A)
- Nuclear Medicine:* 60 credits
- Obstetrics & Gynecology:* 60 credits
- Ophthalmology & Otolaryngology:* 60 credits
- Orthopaedic Surgery:* 60 credits (at least 15, 1-A)
- Pathology:* 60 credits
- Pediatrics:* 60 credits (at least 15, 1-A)
- Physical Medicine & Rehabilitation:* 60 credits
- Preventive Medicine:* 60 credits
- Proctology:* 120 credits
- Radiology:* 60 credits (at least 10, 1-A)
- Surgery:* 60 credits

AOA Credit Categories

- 1A*** **Attendance** at formal, live pre-qualified lectures (available for both outside venue or in-house lectures) - 30% of speakers must hold D.O. degree
Medical Teaching to students, interns, residents, fellows, staff*
- 1B** **GME Faculty/Preceptors** (max 20% of required credits per 3-year cycle; 8 credits max for AOBD diplomats)
Committee/Hospital Staff Work (max 5 CME credits per 3-year cycle; physicians must submit form directly to AOA)
- 2A** **Attendance** at formal programs approved for *AMA PRA Category 1 Credits™* (physicians must submit allopathic CME certificate directly to the AOA)
- 2B** Home study courses, journal-type CME (physicians must submit appropriate form directly to AOA)

*Must be approved by the CME department
Specialty-specific CME no longer required

STATE OF MICHIGAN MEDICAL LICENSE RENEWAL REQUIREMENTS

D.O.'s: 150 hrs. of CME per 3-year period

Category 1 – minimum 60 hrs. (minimum of 40 hrs. must be AOA approved credits)

- **Minimum 40 hours:** Attendance at an **AOA Approved** CME activity related to the practice of osteopathic medicine
- **Maximum 110 hours:** Attendance at an *AMA PRA Category 1 credit* approved osteopathic medicine CME activity
- **Maximum 90 hours:** Serving as teacher, lecturer, preceptor, moderator in board approved medical education or training program
- **Maximum 90 hours:** Member of committee, board, council, or association related to the practice of osteopathic medicine

Category 2 – maximum 90 hrs.

- Independently reading peer-reviewed journal (max 90 hrs.)
- Presentation of a scientific exhibit, poster, paper (max 90 hrs.)
